RESOLUTION NUMBER 2011-

**A RESOLUTION CANVASSING THE RETURNS OF THE
NOVEMBER 8, 2011 FRANCIS CITY MUNICIPAL
GENERAL ELECTION**

WHEREAS, Francis City called an election and directed that it be held on November 8, 2011 pursuant to Utah law for the purpose of choosing two members of the City Council; and

WHEREAS, said election was duly held and the election officials who conducted the election have made and delivered to the Francis City Council a certificate and return regarding the results of the election; and

WHEREAS, Utah Code Section 20A-4-301 provides that the Mayor and City Council are the Board of Canvassers for Francis City elections; and

WHEREAS, Utah Code Section 20A-4-301 directs the Board of Canvassers to meet to canvass the returns of a municipal general election no sooner than seven days after the election and no later than 14 days after the election; and

WHEREAS, Utah Code Section 20A-4-304 directs the Board of Canvassers to declare "elected" those persons who had the highest number of votes who sought election to a City office; and

WHEREAS, the City Council, acting as the Board of Canvassers, has reviewed all necessary matters regarding the election and is ready to declare the results thereof.

NOW THEREFORE, be it hereby RESOLVED by the City Council of Francis City, Utah, as follows:

Section 1: The Board of Canvassers certifies the following as the accurate and final numbers of votes cast by registered voters for each of the candidates at the November 8, 2011 Francis City Municipal General Election:
